- There is available space at the Market
- The application is received at least 2 business days prior to their first Market

Vendors must be in accordance with all regulations set by the Timiskaming Health Unit, including holding a Food Handler's Certificate if selling prepared foods.

Highlighted KLFAM Rules and Regulations

- 1. Vendors can set up as early as 12:30 p.m. and are required to be on site no later than 2:30 p.m. Vendors must be ready for the market opening at 3:00 p.m. and stalls are to remain set up until 6:00 p.m., unless arranged with the Activity Coordinator.
- 2. All vehicles are to be moved outside of Civic Park **immediately** after unloading to leave space for other vendors to unload during set up. Absolutely no vehicles should be inside of Civic Park after 2:30 p.m., unless arranged with the Activity Coordinator. We ask that all vendors drive with extreme caution with windows rolled down while inside Civic Park.
- 3. Vendors not on site by 2:30 p.m. forfeit their stall location. Planned absences are to be made to the Activity Coordinator by no later than Friday at 3:00 p.m. prior to the absence.
- 4. The Activity Coordinator has the final say in the daily operations of the market. Any concerns can be made in writing and submitted to the Activity Coordinator or the Director of Community Services if the Activity Coordinator is unable to resolve concerns.
- 5. An appropriate and respectful attitude towards other vendors, the public, Town of Kirkland Lake staff, and the Kirkland Lake Food & Artisan market is to be always maintained.
