- Council approved the Minutes of its Regular Meeting held on [February 18, 2025](#), and received those as presented by Committees of Council and Regional/Local Boards.
- Council received a delegation from the Kirkland Lake Minor Hockey Association (KLMHA) supporting a request to extend the ice season into April.
- Council received the Town's [2025 Corporate Business Plan](#).
- Council received the [2025 Town Budget, as tabled](#), and directed that a [Public Meeting](#) be held on March 18, 2025 at 4:40 PM to allow for public comment.

- Council delegated their authority to the Director of Public Works in the execution of a [Facility Use Agreement](#) with Team Northern Throttle (TNT) For Family Events for the use of the Kirkland Lake Airport to host their annual Summer Drag Race events inclusively from June 18-23, 2025 and July 16-21, 2025.

- Council authorized to extend the [2024-2025 Winter Ice Season](#) and directed to amend the recommendation to identify that, annually, the ice season be extended to the end of April moving forward.
